2. All blanks are confined to Notice Inviting Tender (BSNL W-6) and Schedules A to F.
3. Authority approving the Notice Inviting Tenders (NIT) shall fill up all the blanks in BSNL EW-6, and in Schedules B to F before issue of Tender Papers.
4. The intending tenderers will quote their rates in Schedule A
5. The proforma for registers and Schedules A to F are only for information and guidance. These are not to be filled in the Standard Form. The Schedules with all blanks, duly filled, shall be separately issued to all intending tenderers for filling and returning the same in the manner prescribed. SPECIAL CONDITIONS OF CONTRACT

1. Tender with conditions i/c conditional rebates shall be summarily rejected.
2. Tenderer is required to work in accordance with agreement with the specifications attached. Where specific specifications are not mentioned, IS – specification, IE rules, CPWD external and internal specifications etc. shall be followed.
3. Tenderer have to agree on testing prescribed by the Engineer – in – charge.
4. Layout diagram shall be approved by the Engineer – in – charge before execution of work.

Before tendering, the contractor shall inspect the site and fully acquaint himself about the condition with regard to accessibility of site and site nature and the extend of grounds, working condition, including stocking of materials, installation of T&P etc., and conditions affecting accommodation and movement of labour etc., required for the satisfactory execution of the contract. No claim whatsoever on such account shall be entertained by the BSNL in any circumstances.

6. a) Earnest Money amounting to Rupees As mentioned above in the form of demand draft/ FDR/ BG/ CDR of a nationalized/scheduled bank guaranteed by the Reserve Bank of India, drawn in favour of **ACCOUNTS OFFICER(CASH), O/O THE GMTD, MEGHALAYA SSA, BSNL,** must accompany each tender and each tender should be in two sealed covers, 1st cover containing the EMD in proper form and 2nd cover containing tender, superscribed as " Tender for the work of As mentioned above and addressed to EXECUTIVE ENGINEER(E), BSNL, ELECTRICAL DIVISION, SHILLONG The Validity period of EMD is 120 days, from the date of opening of tender. In case of e-tendering, each tender should be in two sealed covers, first containing credentials for meeting the Eligibility conditions along with the cost of tenders and EMD in proper form, and second cover containing tender documents. The credentials shall be self attested and certified by any BSNL Executive. If not certified by BSNL Executive then original documents shall be produced at the time of tender opening. After verification of the contents of this envelope then second envelope containing the bid document shall be opened.

b) The EMD of all the unsuccessful tenderers shall be released on issue of award letter to the successful tenderer. This shall be done within one week of award letter.

c) Exemption from payment of earnest money and security deposit by any other unit/ department shall not hold good for BSNL.

7. IMPORTANT INSTRUCTIONS TO BIDDERS DOWN LOADING THE TENDER DOCUMENT FROM WEB SITE :

The bidders, who have down loaded the tenders from the web site, shall read the following important instructions carefully before quoting the rates and submitting the tender documents.

(i) The tenderer should see carefully and ensure that the tender document containing all the pages as per the index has been down loaded for making required entries. The balance pages of Standard BSNL EW-8 form will be attached with the agreement after the award of work.

(ii) A clear print out of tender document shall be taken on good quality A4 size paper and the printer settings, etc., shall be such that the document is printed as appearing in the web and without any change in format, number of pages, etc., and shall also ensure that no page is missing. Only original computer printout of the document shall be used. Photocopy shall not be accepted.

(iii) In case of any doubt in the downloaded tender, the same shall be got clarified from the Engineer -in -charge calling the NIT before submission.

- (iv) The name of the bidder shall be filled on the relevant pages of tender document and all the pages shall be invariably signed. (With stamp).
- (v) The tenderer shall ensure that the downloaded tender document is properly stitched before submitting the document.
- (vi) There shall be no correction / addition / alteration / omission made in the text of the downloaded tender document. If found otherwise, the same shall be treated as non-responsive and rejected.
- (vii) The bidders downloading the tender document are required to submit the **Tender fee** (along with applicable GST) amount through DD/ Banker's cheque along with their tender bid failing which the tender bid shall be left archived unopened/ rejected.
- (viii) The tenderer shall furnish a **Declaration** (appended as **Annexure-II**) to this effect (**in case of downloaded tender**) that no addition / deletion/correction have been made in the tender document submitted and is identical to the tender document appearing on website .Every page of downloaded tender shall be signed by the tenderer with stamp (seal) of his firm /organization.

8. (a) Submission of Tender : The tenderer shall submit the tender in two numbers of separate sealed Covers, marked as **Cover - I** containing the receipt for cost of tender paper and EMD in proper form (**in case of issued tender**) & **Cover-II** containing tender documents. Both the Envelopes should be super scribed as "Tender for the work " _____."(Name of Work) If Cover-I is not annexed or the documents submitted in the Cover-I are found incomplete or not in proper form against requirements as given above herein, then Cover-II containing price bid will not be opened at all and shall be returned to the tenderer on the spot, if the tenderer is present at the time of tender opening.

8 (b) The **cover-1** in case of **DOWNLOADED TENDER** shall contain:

- (i) The Self attested copy of Valid Pan Card.
- (ii) The Self attested copy of Valid GST Registration Certificate.
- (iii) The Self attested copy of Valid Enlistment certificate issued by BSNL, if applicable.
- (iv) The Self attested copy of Valid Electrical License issued by Govt of *Meghalaya/ Assam, whichever is applicable*.
- (v) Tender Fee in proper format.
- (vi) EMD in the prscribed format.
- (vii) The Self attested copy of Valid EPF & ESI Registration certificate, if applicale.
- (viii) Certificate of work experience issued by Officer not below the rank of Executive Engineer (E).
- (ix) Documents fulfilling Eligibility criteria (Please note that in case the bidder is authorized by the manufacturer, the original authorization letter is to be scanned and uploaded).
- (x) Turn over certificate issued by Chartered Accountant.
- (xi) A self-declaration along with the evidence that the bidder is not black listed by GST authorities.

8 (c) " **If Cover-I IN CASE OF DOWNLOADED TENDER** is not annexed or the documents submitted in the Cover-I are found incomplete or not in proper form against requirements as given above herein, then Cover-II containing price bid will not be opened at all and shall be returned to the tenderer on the spot, if the tenderer is present at the time of tender opening.

9. i) Performance Guarantee: The contractor is required to furnish performance guarantee for an amount equal to 5% of the contract value in the form of bank guarantee / CDR/FDR/DD (of a nationalized / Scheduled Bank in a standard format) within two weeks from the date of issue of award letter. This period can be further extended by the Engineer-in-charge upto a maximum period of 2 weeks on written request of Contractor. The validity period of the performance security in the form of performance bank guarantee shall be one year from the date of actual completion of work.

ii) Security deposit: In addition to performance guarantee stated above, a sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum be deducted with the sum already deposited as earnest money, will amount to security deposit of 5% of the Tendered value of the work.

10. The acceptance of a tender will rest with the competent authority, BSNL, who does not bind himself to accept the lowest tender or any other tender and reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. Tenders with any condition including that of conditional rebates shall be rejected forthwith summarily.

11. Canvassing in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.

12. The BSNL reserves itself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.

13. i) The tenderer should give a certificate that none of his/her relative is employed in BSNL units. In case of proprietorship firm, certificate will be given by the proprietor and for partnership firm certificate will be given by all the Directors of the company.

ii) Near relatives of all BSNL employees either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The near relatives for this purpose are defined as:

- a) Members of a Hindu Undivided family.
- b) They are husband and wife.
- c) The one is related to the other in the manner as father, mother, son(s) & son's wife (daughter-in-law), Daughter(s) & daughter's husband(son-in-law), brother(s) & brother's wife, sister(s) & sister's husband(brother -in-law).

The format of the certificate to be given is—

"ISon of Sh Resident ofhereby certify that none of my relative(s) as defined in the tender document is/ are employed in BSNL unit as per details given in tender document. In case at any stage, it is found that the information given by me is false / incorrect, BSNL shall have the absolute right to take any action as deemed fit/without any prior intimation to me".

14. No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractors' service.

15. The tender for the works shall not be witnessed by the contractor who himself/themselves has/ have tendered or who may and has/have tender for the same work. Failure to observe this condition would render tenders of the contractors tendering as witnessing the tender is/are liable for summarily rejection.

16. It will be obligatory on the part of the tenderer to sign each page of the Schedule of work and the tender documents for all the component parts and after the work is awarded he will have to enter into a separate agreement for each component with the officer concerned.

17. Any tender not submitted in proper manner or if it contains too many corrections, over writings of absurd rates, and absurd amount will be liable to be rejected and the BSNL will be at liberty to take such action as it may deem fit without any reference to the tenderer.

CONTRACTOR 18. The tenders for the work shall remain open for acceptance for a period of 30 days from the date of opening of the tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which is not acceptable to the BSNL shall, without prejudice to any other right of remedy be at liberty to forfeit 50% (fifty percent only) of the said earnest money absolutely. SDF(E)/EE(E)

19. Extension of validity: In case, where the letter of award of work cannot be placed within the validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders and the Earnest Money deposit by a reasonable period. In such cases, extension of validity of Earnest Money deposit by 30 days beyond the extended validity date of tender should also be asked for. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the validity.

20. Unsealed tenders will be summarily rejected.

21. The contractor should read the tender documents carefully before submitting the tender.

22. Agreement shall be drawn with the successful tenderer on prescribed form. Tenderer shall quote his rates as per various terms and conditions of the said form, which will form part of the agreement.

23. The tenderer shall furnish a declaration to this effect (incase downloaded tender) that no addition/deletion/correction have been made in the tender document submitted and is identical to the tender document appearing on website. Every page of downloaded tender shall be signed by the tenderer with stamp (seal) of his firm /organization.

24. This Notice Inviting Tender shall form part of the Contract document. The successful tenderer/contractor on acceptance of his tender by the Accepting authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of :-

a) The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

a) Three similar successfully completed works costing not less than the amount equal to 40% of the estimated cost put to tender with DG set capacity not less than 80% of individual capacity of

the DG set proposed in the NIT.

OR

b) Two similar successfully completed works costing not less than the amount equal to 60% of the estimated cost put to tender with DG set capacity not less than 80% of individual capacity of the DG set proposed in the NIT.

OR

c) One similar successfully completed work costing not less than the amount equal to 80% of the estimated cost put to tender with DG set capacity not less than 80% of individual capacity of the DG set proposed in the NIT.

(2) In addition to the above, the bidder should also have the following:

(III) IMPORTANT NOTES FOR CONTRACTORS

1 EARNEST MONEY:

1.1. VALUE:

The amount of Earnest Money to be deposited with each tender is 2% of the estimated cost put to the tender *subject to a maximum of Rs. 2 crores*. Earnest money will be acceptable in the form of CDR / FDR / DD / BG.

1.2 Validity Period

The validity period of the Earnest Money Deposit is kept 30 days beyond the tender validity period.

1.3 Extension of Validity

In case, where the letter of award of work cannot be placed within the validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders and the Earnest Money deposit by a reasonable period. In such cases, extension of validity of Earnest Money deposit by 30 days beyond the extended validity date of tender should also be asked for. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the Validity.

1.4 Release of Earnest Money deposit

Earnest Money deposit of all unsuccessful tenderers should be released on issue of award letter to the successful tenderer. This should be done within one week of issue of award letter.

In case of successful tenderer, the Earnest Money deposit is released on their submitting performance bank guarantee.

Where the BSNL requests the tenderer to extend the validity of the tender beyond the stipulated period given in the tender documents, and the tenderer refuses to extend the validity of his tender, the Earnest Money deposit of such tenderers is returned forthwith.

1.5 Completion of work

At the time of issuing NIT for a particular work, the time allowed for completion of work consistent with magnitude and urgency of work is specified. The time allowed for carrying out the work as entered in the contract is reckoned from the at once after the date on which the orders to commence the work are given to the contractor. To ensure good progress of the work during the execution, the contractor is bound, in all cases, in which the time allowed for any work exceeds one month (except special jobs), to complete 1/8th of the whole of the work before 1/8th of the time allowed under the contract has elapsed, 3/8th of the work before 1/2 of the time has elapsed and 3/4th of the work before 3/4th of such time has elapsed. However, for special jobs, if a time schedule has been submitted by the contractor and the same has been accepted by the Engineer – in – charge, the contractor shall comply with such time schedule.

1.6 Extension of Time

If the contractor shall desire an extension of time for completion of work on the grounds of his having been unavoidably hindered in its execution or on any other ground, he shall apply in writing to the Engineer – in – charge within 30 days of the hindrance on the account on which he desires such extension as aforesaid, and the Engineer – in – charge shall, if in his opinion reasonable grounds to be shown therefore, authorize such provisional extension of time, if any, as in his opinion be necessary or proper.

1.7 Compensation for delay

If the contractor fails to maintain the required progress or complete the work and clear the site on or before the contract or extended date of completion, he has to pay the compensation for delay which is limited to 0.5% per week of work order value for the first 10 weeks and 0.7 % per week for next 10 weeks and thereafter subject to a maximum of 12% of the work order value for the location where the work is delayed and the firm is found responsible for the same. Flow chart of the procurement process / contract shall be supplied by the contractor and approved by Executive Engineer concerned.

1.8 QUALITY ASSURANCE:

The EI works shall be executed in accordance to the CPWD specifications. The work is considered to be completed only after the successful completion of Testing of the system as per CPWD specifications. For EA set Repairing Works the work is considered to be completed after conducting successful load testing with existing Exchange/ Building Load. For HT line work the work is considered to be completed only after obtaining clearance from Electrical Inspector. Responsibility lies with the contractor to get the clearance for construction of HT line and charging of HT line from the Electrical Inspector of the local Electrical Inspectorate / Electricity Authority / Board.

1.9 Determination of Contract

The Engineer – in – charge may determine the contract in respect of any delay, inferior workmanship as per clause 3 of EW-8 contract conditions.

1. 10 INCREASE/DECREASE OF TENDER QUANTITY :- BSNL will have the right to increase / decrease up to 50% of the quantity of goods and services specified in the schedule of items without any change in the unit price or other terms and conditions at the time of award of contract. In exceptional and unavoidable cases BSNL can increase the quantity of goods and services beyond 50% of the tendered quantity without any change in tendered and accepted unit price and also other terms and conditions as applicable at the time of award of contract.

1. 11 OPERATION OF RATE CONTRACT

(a) The operation of this Rate Contract shall be governed by the General Rules and conditions of the Contract.

(b) Signing of Contract:-

The successful tenderer /contractor, on acceptance of his tender by the Accepting Authority, shall sign the contract within 15days consisting of the notice inviting tender, all documents including drawings, if any, forming the tender as issued at the time of invitation of tender & acceptance thereof together with any correspondence leading thereto.

1. 12 CURTAILMENT OF QUANTITY:-

BSNL reserves the right to enforce curtailment in the assigned quantum of work for any contractor on the grounds of defaults/delay in regard to execution of the individual work assigned

1. 13 VARIATION IN GST:

In case of any statutory variation in regard to Input tax credit, within the currency of individual agreement including extension of time period, the same shall be admissible as per actual Input tax credit only, subject to the condition that the reason for such extension of time period is not attributable to the agency.

1.14 Performance Review

In order to view the performance of the firms and to suggest the suitable corrective measures, performance review committee reviews the performance of Air conditioning and Engine Alternator firms annually at Head Quarter level, whereas the performance review of Substation, Fire Detection & AVR firms is done at CE(E) level. Firms whose performance not found to be satisfactory are blacklisted for a suitable period.

1.15 COMPLETION PERIOD:

The period of completion of work will be within stipulated time of 30 days from the date of issue of work order.

2 PAYMENT TERMS:

No advance payment will be made. The payment terms shall be governed as per **Clause-7 of BSNL EW-8**. No payment will be made for goods rejected at the site. Payment, if made, for such items shall be recovered from subsequent bills or other bills. Stipulations like levy of interest if payment is not made in specified time are not acceptable to the BSNL.

Payment of specified percentage of the price (As per BSNL EW 8) shall be made on receipt of goods by consignee. For claiming this payment the following documents are to be submitted to the paying authority.

(a) Invoice clearly indicating break up details of composite price i.e. Basic, Goods and Services Tax (GST), any other Duties and Taxes, Freight/Packing Charges, etc.

(b) Acknowledged Delivery Challan in original.

(c) Inspection Certificate of QA(Payable copy in original)

(d) The sea freight receipt as per the rates approved by the Ministry of Water and Surface Transport, if applicable.

(e) E-way bill as prescribed in the GST law in case of movement of goods

(f) Proof of payment of GST, if applicable.

(g) Timely uploading of correct and necessary information on GSTN portal is mandatory as prescribed in GST compliances.

Note :- 1) If the supplier fails to furnish necessary supporting documents i.e. GST invoice / Customs invoices etc. and also fails to upload the information on GSTN in respect of the Duties/taxes for which input tax credit is available, the amount pertaining to such Duties/Taxes will be deducted from the payment due to the supplier.

2) Tax amount will be paid to the supplier only after supplier declares the details of the invoices in its return in GSTR 1 and GSTR-3 uploaded by the supplier and the same is reflected in GSTR-2A of BSNL on GSTN portal .

3) TDS/ TCS shall be deducted at the prescribed rate, if any (as the case may be).

4) BSNL can adjust/ forfeit Bank Guarantee obtained from the supplier against any loss of input tax credit to BSNL on account of supplier's default.

5) In case BSNL has to pay GST on reverse charge basis, the supplier would not charge GST on its invoices. Further, the supplier undertakes to comply with the provisions of GST law as may be applicable.

2. 1. In Addition to the above conditions the following technical conditions are to be fulfilled before making payment to the contractor

The tests reqd pertaining to the type of equipment / installation to be conducted by the concerned SDE / JTO in presence of the departmental staff / contractor for satisfactory operation of that equipment to the satisfaction of the Department as per the condition given in the agreement.

3 TAX INDEMNITY CLAUSE :

(i) BSNL has the right to recover Input Tax Credit loss suffered by it due to any mis-declaration on invoice by the supplier.

(ii) In case the supplier gets black-listed during the tenure of BSNL contract, it is to be ensured that no loss of Input Tax credit is borne by BSNL due to a default of supplier.

(iii) It is hereby agreed between both the parties that in case any GST and/ or cess liability, interest, penalties or any other tax/ duty/ amount/ charge/ liability / professional costs related to litigation becomes payable by BSNL or input tax credit is denied to BSNL due to failure of the supplier to comply with the relevant laws/ regulations applicable in India or overseas, Supplier undertakes to indemnify BSNL for an amount equal to amount payable by BSNL and the same shall be recovered by BSNL

4 BID PRICES:

(i) The bidder shall give the total composite price inclusive of all levies & taxes i.e. Custom Duty Goods & Services Tax on packing, forwarding, freight and insurance and Entry Tax as applicable etc. The offer shall be in Indian Rupees. No Foreign Exchange will be made available by the purchaser. This basic unit price and all other components of the price need to be individually indicated up to two decimal points only against the goods. The offer shall be in Indian Rupees only.

(i) Documentary proof of GST Registration.

(ii) All the taxes and duties will be as per applicable GST. Since GST qualifies for input tax credit. Agency should separately quote GST components. To avail of applicable input tax credit by BSNL, the firm shall have to submit Tax invoice showing GST components with Service Code while claiming bills.

(iv) GST and any other tax applicable in respect of this contract shall be borne by the bidder himself. The bidder shall quote his rates considering all such taxes. The TDS as per the Govt. regulations will be recovered from the contractor.

v) The Contractor/ Supplier shall quote as per price schedule for all items given in the Schedule of quantities given in the **“Schedule-A”**.

(vi) A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.

(vii) The price quoted by the bidder shall be in sufficient details to enable the Purchaser to arrive at the price of equipment/ system offered.

(viii) **“DISCOUNT” if any, offered by the bidders shall not be considered unless specifically indicated in the price schedule. Bidders desiring to offer discount shall therefore modify their offers suitably while quoting and shall quote clearly net price taking all such factors like Discount, free supply etc. into account.**

(ix) The price approved by BSNL for procurement will be inclusive of levies and taxes, packing, forwarding, freight and insurance etc.

5 EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS

(a) The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices offered inclusive of packing, forwarding, freight and insurance charges etc., but excluding GST. The bid with lowest net cost as elaborated above will be the L1 bidder.

(b) The evaluation and comparison of responsive tenders shall be done on the basis of net cost to BSNL, considering GST as Input Tax credit.

(c) Vendor should furnish the correct GST Rates in the price schedule. If the input Tax credit is found to be not admissible at any stage subsequently owing to wrong furnishing of GST Rates, then the vendor will be liable to refund such non admissible amount, if already paid, along with penalty if charged by the concerned authority.

(d) In case the Duties, Taxes and Cesses which are not eligible for input tax credit as per the quotes indicated in the price schedule by the suppliers and subsequently at any stage it is found that Credit for such Duties, Taxes and Cesses is admissible as per provision of GST law, then the supplier will be liable to refund the amount equivalent of such Duties, Taxes & cesses if already paid to them provided the credit can be claimed within the time prescribed under the applicable legislation and BSNL has all documents to claim such credit. The refund is also subject to the bidder performing necessary act for enabling BSNL to claim the credit viz. upload the information on GSTN. However, the purchaser may allow the supplier to submit necessary documents in this regard which may enable the purchaser to avail the input tax credit provided such credit is still available for the amount so paid as per provision of GST law.

(f) BSNL can adjust/forfeit bank guarantee obtained from the supplier against any loss of input tax credit to BSNL on account of supplier's default.

(g) In case BSNL has to pay GST on reverse charge basis, the supplier would not charge GST on its invoices. Further, the supplier undertakes to comply with the provisions of GST law as may be applicable.

(h) If the supplier fails to furnish necessary supporting documents that is GST invoice/custom invoices etc and also fails to upload the information on GSTN in respect of the duties/taxes for which input tax credit is available, the amount pertaining to such duties/taxes will be deducted from the payment due to the supplier.

(i) Payment against GST credit will be made only when GST compliant invoice is submitted by the supplier.

(j) GST (if applicable) on account of liquidated damages due to delay in supply of goods would be borne by supplier.

6 The firm shall read carefully the following conditions and shall quote accordingly confirming all the points in their offer.

(a) Department reserves the right to accept the quantities in full or in parts.

(b) Department reserves the right to send authorized representative to witness the test if felt necessary.

(c) Since the contract period of this work is less than eighteen months therefore Clause **10(CC)** will not be applicable as per section 32.8.2 of CPWD Manual.

7 Rates quoted by the contractor shall be firm and shall be valid for the currency of contract. No cost escalation shall be permitted during the currency of contract.

8 PROGRAMME FOR EXECUTION:

(a) The firm shall supply the detailed programme to the Engineer-in-charge within seven days award letter. The programme shall contain details about submission of drawing & tentative dates for inspection/testing by the department.

(b) The firm shall get the layout approved from the Engineer-in-charge. The approval of layout drawings will not absolve the firm from its responsibilities for supplying and installing the system in accordance with the relevant specifications/ codes/agreement conditions.

9 QUALITY ASSURANCE

The EI works shall be executed in accordance to the latest CPWD specification. The work is considered to be completed only after the successful completion of Testing of the system as per CPWD specification pertaining to that particular type of work.

10 STORES AND MATERIALS:

All the stores and materials required for the work except those specified, as departmental supply shall be arranged at work site by the firm from his own resources or open market. It should be clearly understood that no claim whatsoever should be entertained by the department on this account. Safe custody of the materials brought at site shall be firm's responsibility till the installation is taken over by the department after successful testing & commissioning. However a lockable space may be provided by the department on intimation well in advance before receipt of material at site. Accommodation for erection crew will not be provided by the department.

11 CO-ORDINATION:

Generally more than one agency is working at the same premises. It shall be the aim of agencies that on their account the work of the other agencies is not delayed. Full co-ordination and co-operation shall therefore be extended during the execution of the work to ensure prompt and quality work.

12 SPECIAL CONDITIONS:

(i) The firm should note that offers with condition and / or conditional rebates will be summarily rejected.

(ii) The layout of the work will be given by the Engineer-in-Charge or his duly authorized representative at site of works.

(iii) The contractor has to test the system for the insulation and continuity for which nothing extra is payable.

(iv) The contractor has to arrange the following test failing which the Rs. 500.00 (Rupees five hundred only) will be recovered from his final bill.

· For EI Work: - Insulation test, Continuity test, Earthing test and Test Report.

· For AC Repairing Works : Successful cooling testing with existing Exchange/ Building Load.

(v) Any damage done to the building during the execution of work will have to make good at the entire satisfaction of Engineer-in-Charge.

(vi) Items which are not included in the "list of approved makes" only ISI marked material shall be used. In case ISI marked is not available in particular item, material conforming to BS, shall be provided.

13 (i) TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR:

Without prejudice of any of the rights or remedies under this contract, if the contractor dies, the Engineer-in-charge on behalf of the BSNL shall have the option to terminating the contract without compensation to the contractor.

(ii) INDULGING OF CONTRACTOR IN CRIMINAL/ANTISOCIAL ACTIVITIES AND CASES UNDER INVESTIGATION/CHARGE SHEETED BY CBI OR ANY OTHER GOVERNMENT AGENCIES ETC:

If the CBI/Independent External Monitor (IEM)/ Income Tax/ sales Tax/ Central Excise/ Custom Departments recommended such a course- action will be taken as per the directions of CBI or concerned department.

1. The work shall be done as per current CPWD specifications, electrical works as embedded from time to time and Indian Electricity rules as amended up to date.
2. The work shall be supervised by qualified technical staff.
3. The layout of the work will be given by the Engineer-in charge or his duly authorized representative at site of work.
4. The following works shall be done on separate conduits
 - a) Power plug wiring.
 - a) Light and fan point wiring.
 - b) Emergency light point wiring. (AC supply/DC supply)
 - c) Telephone wiring.
 - d) Clock wiring.
 - e) AC units wiring.The number of power plug points and emergency light points fed from the DC supply shall not exceed to per circuit in any of the cases.
5. The earthing sets shall be provided in the presence of Engineer-in-charge or his authorized representative.
6. Sample of all the materials, fittings, accessories, IC switch gears, etc. Shall be got approved from the Engineer-in charge before using the name on the work. The rejected materials shall be removed immediately from the site of work.
7. The contractor shall have to submit the completion plan as clause 6(A)1,6(B) of the agreement within 30days of the completion of works. Failing to submit the completion plan, he will be liable to pay a sum equivalent 2.5% of the value of work subject to a ceiling of Rs.2,500/- as per the clause 6(A)1, 6(B) of the agreement.
8. The contractor will have to give the following tests at his cost and intimate test results before final bills are paid. Nothing extra will be paid on this account.
 - a) Earth test. B) Polarity Test. C) Insulation Test. d) Extra continuity test of the surface/recess conduit pipes.
9. Any damage done to the building by the contractor during the execution of work shall have to be made good at his cost and risk. If he does not do it himself within a reasonable time (determined by the Executive Engineer (E) then same will be got done at his cost departmental after giving notice to him.
10. The outlet boxes I.C boxes for switches and end of conduits etc. for different categories of conduit runs catering for different types of electrical wiring as mentioned in clause above shall be painted 8inside/outside with different colour each signifying the decrement categories mentioned so as to avoid mixing of various circuits and their wiring and nothing extra will be paid for this.
11. In the time laying conduit pipe in the slab and in recess, the contractor will keep fish wire of 16 SWG GI wire through out conduit pipe and will have to take special care so that the conduits do not pass through air-conditioning ducts, grills columns, if any such necessity is foreseen special written permission of E.E.(E) will be obtained before such works is carries out. In case of failure, the contractor will not be paid on this account. The successful tendered should reason the conduit in the wells before they are plastered and in collaboration with building work in progress. Any damage thus done will have to be made good at the cost electrically continuous.
12. The bakelite covers for the tumbler switches plug sockets etc shall be removed or broken for taking connections which shall be done at their back be providing suitable wooden rider in the I.C. boxes where found necessary. All I.C boxes for switches, plug and regulators etc. Shall be provided 1/8" thick bakelite sheet covers.
13. The runs of various circuit wiring at various places shall kept minimum by taking the runs on wall where crossing of columns is not necessary. This has to be decided before casting of slab so that unnecessary length of conduits are not laid therein.
14. All the I.C. distribution board, Sub-main board and their complete fitting shall be sign-written clearly indicating the No of distribution board, the type of load it is serving and the number of circuit contained in the distribution box shall be placed in a tabular form the reverse of the cover of the distribution box.
15. Underground cables both of 1.1KV and 1.1KV grade should be subjected to pressure/insulation tests before and after laying the same in the ducts. Incase of unsatisfactory test the cost of all replacement and extra work of removal and relaying well have to be made good by the contractor at his own risk.
16. While make the end connections of wires, no strand shall be cut and the termination of wires shall be done with necessary lugs and ferrules without any extra payment.
17. The bus bars of the single phase distributions box shall be strip instead of sheet metal.
18. The lugs should be provided while terminating 8 SWG G.I wire for earth continuity without any extra payment.
19. The contractor will have to make arrangement to take the material to site of work at his own risk. Octori, if paid by the contractor for the materials supplied by the department the same can be claimed by him against original voucher.
20. If any conduits laid before the award of this work, the recovery for the same will be made from the contractor at the rates specifications in the SR-94(internal)plus the enhancement of this tender. Or the rates quoted by the firm in the tender for the work.
21. The Department shall not supply any tools and plants unless otherwise specified.

NOTE: In addition to above the work should be carried out as per latest CPWD/ BSNL specification pertaining to the work, ammended up to date and as per the direction of the Engineer - In - Charge .
