- (vii) If the Vendor / supplier does not disclose the correct details on the invoice or on the GSTN viz GSTIN, Place of supply etc. which restricts BSNL to claim input tax credit, then the amount pertaining to such Duties, Taxes and Cesses will be deducted from the payment due to Vendor/suppliers.

- (xi) Tax indemnity clause: BSNL has the right to recover Input Tax Credit loss suffered by it due to any miss-declaration on invoices by the supplier.

- 3 <u>EVALUATION OF BIDS</u>:-The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices of all items included in schedule of work offered inclusive of packing, forwarding, freight and insurance charges but excluding Input tax credit/GST. 6 VARIATION IN GST:

- In case of any statutory variation in regard to Input tax credit, within the currency of individual agreement including extension of time period, the same shall be admissible as per actual Input tax credit only, subject to the condition that the reason for such extension of time period is not attributable to the agency.
- 7 (a) Tendered rates are inclusive of taxes and levies payable .However, pursuant to the Constitution (Forty Sixth
