- (vi) There shall be no correction / addition / alteration / omission made in the text of the downloaded tender document. If found otherwise, the same shall be treated as non-responsive and rejected.

(v) The tenderer shall ensure that the downloaded tender document is properly stitched before submitting the document.

- The acceptance of a tender will rest with the Executive Engineer (E) **BSNL Electrical Division, Shillong** who does not bind himself to accept the lowest tender

or any other tender and reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.
