- 1 ELIGIBILITY CRITERIA The Contractors satisfying the following conditions:
  - 1.1 Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost put to tender
 

AND
  - 1.2 BSNL enlisted contractors in Electrical category of respective class as per their tendering limits.
 

OR
  - 1.3 The Contractors satisfying the following conditions:

The contractor enlisted in CPWD/ M.E.S /Railways/ Mizoram State Govt for carrying out Electrical works in respective class as per their tendering limits/Having valid Electrical Licence issued by the state Govt / Specialized Agencies having experience in similar nature of works

OR

Experience of having successfully completed similar works in Central Government /State Government/Central Govt. Autonomous Body/Central Govt. Public Sector Undertaking during last 7 years ending last day of the month previous to the one in which NIT applications are invited , should be either of the following:-

- A In addition to above, the contractor must have valid Electrical License issued by any State Government under clause 45 of I.E.R1956 or as amended from time to time only for Electrical work except specialized agencies, The contractor /firm should have Valid Goods and services (GST) registration certificate Number eligible for raising GST Tax invoice to BSNL for claiming input tax credit & shall possess registration/license from appropriate labour authority, EPF & ESI registration
- B Similar Work means for Electrical works such as Electrical Installation Fans and Fittings, Service connection, earthing works. Specialized work means such as Supply or Maintenance of Substation works, air-conditioning , DG set works, Automatic Fire Detection works etc

Note2 The estimated cost of one year shall be considered to evaluate the eligibility criteria.

**SPECIAL NOTE FOR ALL THE WORKS:**

- 1 "Similar work" shall be properly defined and appropriately indicated in the eligibility criteria by the NIT approving authority.
- 2 For Rate Contract works, the eligibility criteria shall be derived based on capacity and estimated cost put to tender for one typical job. However, turnover shall be evaluated based on the total estimated cost put to tender.
- 3 In respect of the works not covered herein above, the PCEs/Sr CEs/CEs(Elect) may decide the eligibility criteria.

- 1 The contractor/firm has to submit an undertaking (duly signed, in the format enclosed with the NIT) that he shall abide by the original standard forms PWD-6 and 8.BSNL forms.

**DECLARATION OF RELATIVES**

**(To be given by Tendering Agency)**

All near relatives of any BSNL employee either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The detailed guide lines in this regard are given in the following paragraph.

- i) The near relatives for this purpose are defined as:-
- (a) Members of a Hindu Undivided family.
  - (b) They are husband and wife.
  - (c) The one is related to the other in the manners as father, mother, son(s) & son's wife (daughter in law), Daughter(s) & daughter's husband (son in law), brother(s) & brother's wife, sister's husband (brother in law).
- ii) As per Government of India's CCS conduct rule 4 , No Govt servant shall in the discharge of his official duties deal with any matter or sanction any contract to any company or for any other person if any member of his family is employed in that company or firm or under that person or if he or any member of his family is interested in such matter or contact of his official superior. This clause is applicable to all BSNL employees and in view to this as soon as any BSNL employee becomes aware of the above aspect, he must intimate this to the prescribed authority. For Non-Executive employee this authority is SSA head/ Circle head/Chief Engineer / Chief Arch./ Corporate Office under which he is posted. For Executive employee (at Present some of them are called Gazetted Officers) the prescribed authority for this purpose is Circle head/Chief Engineer / Chief Arch./ Corporate Office under whom he is posted.
- iii) (a) The company or firm or any other person is not permitted to tender for works in BSNL unit in which his near relative(s) is/are posted. The unit is defined as SSA/Circle/Chief Engineer / Chief Architect / Corporate Office for executive employees (including those called as gazetted officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the unit as defined above where he is going to apply for tender/work. In case of proprietorship firm certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and EMD / SD will be forfeited at any stage whenever it is so noticed. The department will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.
- (b) In respect of case where the tender notice / work related orders have been issued and are waiting for submission the concerned unit should issue corrigendum for inclusion of above clause. However , here tender / work related documents have been opened and are waiting for finalization the certificate may be taken from the company or firm or any other concerned person giving details of the relative employed in the jurisdiction of the tender. The company or firm or the person concerned will not be debarred in this case but his work will be kept under proper watch to avoid any further complaint. Further, the relative will not be involved in the decision making & execution of the work.
- (c) Where the tenders or the work are already in operation (or awarded) the tenderer may be requested to give details of relatives employed in the jurisdiction of the tender in such cases the tenderer will be allowed to continue the work but special watch may have to be kept about his performance to avoid any complaint. - 1 The firm shall read carefully the following conditions and shall quote accordingly confirming all the points in their offer.
- 2 The bidder shall quote only Net rate excluding GST on Goods & Services. All taxes except CGST, SGST, UTGST and IGST if any, required to be paid on the invoices shall be borne by the supplier. The Labour welfare Cess & TDS as per the Govt. regulations will be recovered from the contractor. No concession form will be issued by the BSNL.
- 3 No additional condition whatsoever will be accepted for Turn Over Tax / Sales Tax / GST on works contract. In case of additional conditions for the payment of such taxes by the contractor the tender may be liable to be summarily rejected by the accepting authority. No conditional offer shall be entertained and the offer will be rejected.
- 4 Firm has option to deposit Earnest Money in form of Bank Guarantee for this work in attached format and manner wherever the amount of EMD is more than Rs. 20,000/-
- 5 All materials to be used on this work by the contractors shall be got approved from the Engineer -in-charge before installation at site. Unapproved materials if brought to site of work shall have to be removed immediately by contractor at his cost and risk.

- 15 Arbitration:** Except where otherwise provided in the contract all disputes relating to the meaning of the specification, design, drawing and instruction or as to the quality or workmanship or materials used in the work or arising out of them or/ and conditions of the contract during the progress of the work or after completion or abandonment thereof shall be referred to the sole arbitrator by the C.E. (Electrical) BSNL as per the clauses of contract.
- 16 Deduction towards taxes:** 2% of the payment due to the firm or as applicable shall be deducted at the time of payment towards the income tax payable by them and shall be remitted to the Income Tax Department and certificate to this effect will be issued to the firm on each occasion of payment.
- 17 Agreement:** The firm has to enter into the agreement on acceptance of his tender within 07 days of issue of letter of approval to them, failing which earnest money will be forfeited.
- 18 Taxes:** The firm shall include all taxes and duties as applicable on date except GST. If any new tax is levied, by the Government on maintenance contracts after opening of tender the same shall be reimbursed by the B.S.N.L on production of proof of payment. No any concessional form shall be issued by BSNL. The bidder shall quote only Net rate excluding GST on Goods & Services. All tax esexcept CGST, SGST, UTGST and IGST if any, required to be paid on the invoices shall be borne by the supplier. The Labour welfare Cess & TDS as per the Govt. regulations will be recovered from the contractor.
- 19 GST :** - Contractor shall submit invoice (Bill) duly segregating the amount of work executed excluding GST amount & GST amount along with Invoice no (bill no.) and all other details required under GST act. The Service receiver (BSNL) shall pay to contractor Gross amount of work executed i.e including GST duly deducting all other leviable taxes like I/Tax etc as applicable. The Contractor, as a service provider, shall be liable to pay GST amount to respective authority himself where as the service receiver (BSNL) shall deposit all other taxes deducted to concerned authority. Percentage rate of GST for various type of goods / Services as finalised by GST council can be obtained from the website www.cbec.gov.in. It shall be the responsibility of Vendor to raise appropriate tax invoice as per the provisions of GST Act. BSNL reserves the right to be indemnified for the credit loss in case BSNL is unable to claim the input tax credit for any non-compliance/ default in raising appropriate invoice by Vendor. Further all invoices should be sent to BSNL promptly.
- 20 STANDING ORDER NO. 258 :-**(i) Tendered rates are inclusive of taxes and levies payable under the respective statutes. However pursuant to the Constitution (Forty Sixty amendment ) Act 1982, if any further tax or levy is imposed by tatute after the date of receipt of tenders and the contractor(s) thereupon necessarily and properly pays taxes or levies the contractor(s) shall be reimbursed the amount so paid provided such payment if any is not in the opinion of S.E.(E) whose decision shall be final and binding) attributable to delay in execution of work within the control of the ontractor(s).
- (ii) The contractor(s) shall keep necessary books of accounts and other documents for the purpose of this condition as may be necessary and shall allow inspection of the same by a duly authorized representative of Government and shall furnish such other information /documents as the Engineer-in-Charge may require.
- (iii) The contractor(s) shall within a period of 30 days of imposition of any further tax or levy pursuant to the constitution (Forty Sixty amendment) Act 1982 give a written notice thereof to the Engineer-in-Charge that the same is given pursuant to this condition together with all necessary information relating thereto. NOTE : No additional ondition whatsoever will be accepted for turnover tax/sales tax on works contract. In case of additional conditions for the payment of such taxes by the Contractor the tender may be liable to be summarily rejected by the accepting authority.
- 21 Compensation for delay:** If the contractor fails to maintain the required services within the contract period or extended date of the contract period, he has to pay the compensation for delay which is limited to 1% per week of proportionate value of work order and thereafter subject to a maximum of 12% of proportionate value of the work order for the exchange where the work is delayed and the firm is found responsible for the same.

- 23 Increase / Decrease of Tendered Quantity :-**
- (a) BSNL will have the right to increase or decrease up to 25% of the contract value depending upon the requirement of goods and services specified in the schedule of items without any change in the unit price or other terms and conditions at the time of award of contract.
- (b) In exceptional situation where the requirement is of an emergent nature and it is necessary to ensure continued supplies from the existing venders, the purchaser reserves the right to place repeat order up to 50% of the quantities of goods and services contained in the running tender /contract within a period of twelve months from date of award of work at the same rate or a rate negotiated (downwardly) with the existing venders considering the reasonability of rates based on prevailing market conditions and the impact of reduction in duties and taxes etc.
- 24** Loading, unloading, transportation, insurance etc shall be included in their offer.
- 25** All the material will be under the charge of contractor till it is completed and handed over. No materials will be removed from site without written permission of Engineer in charge.
- 26 (a) Termination of contract on death of contractor**
- Without prejudice of any of the rights or remedies under this contract , if the contractor dies, the Engineer in-charge on behalf of the BSNL shall have the option of terminating the contract without compensation to the contractor.
- (b) Indulging of contractor in criminal / Antisocial activities and cases under investigation / charge sheeted by CBI or any other Government agencies etc.**
- If the CBI / Independent External monitor (IEM) / Income Tax / Sales Tax / Central Excise / Custom Departments recommends such a course-Action will be taken as per the direction of CBI or concerned department.
