





ELIGIBILITY CRITERIA FOR PARTICIPATION IN TENDERS FOR ELECTRICAL / ELECTRO – MECHANICAL WORKS/ SPECIALISED WORKS – BSNL ELECTRICAL WING

- 1 ELIGIBILITY CRITERIA The Contractors satisfying the following conditions:
- 1.1 Average annual turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost put to tender

AND

OR

- 1.2 BSNL enlisted contractors in Electrical category of respective class as per their tendering limits.
- 1.3 The Contractors satisfying the following conditions:

The contractor enlisted in CPWD/ M.E.S /Railways/ Mizoram State Govt for carrying out Electrical works in respective class as per their tendering limits/Having valid Electrical Licence issued by the sate Govt / Specialized Agencies having experience in similar nature of works

### OR

Experience of having successfully completed similar works in Central Government/State Government/Central Govt. Autonomous Body/Central Govt. Public Sector Undertaking during last 7 years ending last day of the month previous to the one in which NIT applications are invited , should be either of the following:-

a) Three similar successfully completed works costing not less than the amount equal to 40% of the estimated cost put to tender.

#### OR

b) Two similar successfully completed works costing not less than the amount equal to 60% of the estimated cost put to tender.

### OR

c) One similar successfully completed works costing not less than the amount equal to 80% of the estimated cost put to tender

- Note1 The following note A & B is applicable for SI No. 1 & 2 above:
  - A In addition to above, the contractor must have valid Electrical License issued by any State Government under clause 45 of I.E.R1956 or as amended from time to time only for Electrical work except specialized agencies, The contractor /firm should have Valid Goods and services (GST) registration certificate Number eligible for raising GST Tax invoice to BSNL for claiming input tax credit & shall possess registration/license from appropriate labour authority, EPF & ESI registration
  - B Similar Work means for Electrical works such as Electrical Installation Fans and Fittings, Service conection, earthing works. Specialized work means such as Supply or Maintenance of Substation works, air-conditioning, DG set works, Automatic Fire Detection works etc

Note2 The estimated cost of one year shall be considered to evaluate the eligibility criteria.

### SPECIAL NOTE FOR ALL THE WORKS:

- 1 "Similar work" shall be properly defined and appropriately indicated in the eligibility criteria by the NIT approving authority.
- 2 For Rate Contract works, the eligibility criteria shall be derived based on capacity and estimated cost put to tender for one typical job. However, turnover shall be evaluated based on the total estimated cost put to tender.
- 3 In respect of the works not covered herein above, the PCEs/Sr CEs/CEs(Elect) may decide the eligibility criteria.

- 3 Self attested copy of valid GST registration certificate
- 4 Self attested Copy of PAN card.
- 5 Valid Electrical Licence for the electrical work issued by the State Govt. /competent Authority
- 6 EPF Registration certificate self attested or certificate from Notary for not requirement of EPF.
- 7 Self attested copy of ESI Registration certificate or certificate from Notary for not requirement of ESI.
- 8 Duly filled and signed undertaking regarding EPF & ESI Provisions ---as per relevant Page.
- 9 Duly filled and signed Undertaking and to abide by EW6 and EW 8 -- as per relevant Page.
- 10 Tender Submission Undertaking .Declaration by Contractor (I have read/Understood all the terms and conditions as mentioned in bid Document and accept the same unconditionally.( as per relevant Page)
- 11 The tenderer shall submit the tenders in 2 wax sealed cover marked cover lst & IInd. The 1st.cover should contain original / attested copy of the credentials in support of fulfilling the work criteria & other documents as per NIT, the tender cost in form of demand draft in favour of "AO (Cash) BSNL, Aizawl". Payable at -Aizawl and earnest money in the form of CDR/FDR/Demand Draft/BG of a Scheduled Bank or Nationalized Bank / State Bank Guaranteed by Reserve Bank of India or Bank Guarantee in the manner described in SI.No.4 above. In case 1st.cover is not accompanied or Earnest Money is not in proper form then the 2nd. cover containing tender will not be opened and will be rejected.
- 13 (a) The intending tenderers shall invariably sign the undertaking provided with the tender documents. Any failure to do so shall result in rejection of the tenders.
- 13 (b) If any difference / discrepancies are found between downloaded tender form, and hard copy of tender issued from Division office, the contents in draft NIT shall be final & binding.

### IMPORTANT NOTE FOR THE CONTRACTOR/FIRM WHO DOWNLOAD THE TENDER FROM WEB SITE

The contractor/ firm who are down loading the tender form are instructed to go through the following points:-

- 1 The contractor/firm has to submit an undertaking (duly signed, in the format enclosed with the NIT) that he shall abide by the original standard forms PWD-6 and 8.BSNL forms.
- 2 The contractor/firm shall submit the following in FIRST ENVELOPE:-
- a Application on the firm's printed letter-head
- b Necessary documents for credentials for meeting the eligibility conditions.
- c Non-refundable cost of tender documents (in the shape of demand draft).
- d Earnest money (in the proscribed form and of prescribed amount).Bid Security/EMD shall be exempted for MSE/MSME Registered vendors/agencies with appropriate similar category of work as per the amendment to rule 170(i) of Financial rules (GFR) 2017.

(In case of demand draft, separate demand draft for Cost of tender documents and EMD are to be submitted)

- 3 After verification of the documents in FIRST ENVELOPE (i.e. credentials, cost of tender documents and earnest money, etc) and on finding them in order, the SECOND ENVELOPE containing the bid documents shall be opened.
- 4 It shall be the responsibility of the firm to clearly list the documents attached to establish their eligibility credentials in the application (on their printed letter head).
- 5 The credentials submitted shall be self attested and certified by any BSNL Executive (not below the rank of SDE). If not certified by BSNL Executive then original documents shall be produced at the time of tender opening.
- 6 EMD of non-eligible firms shall be returned in original at the time of opening of tender.
- 7 The tenderer has to submit the downloaded original computer print out of the documents from the web site. The photocopy shall be not accepted.
- 8 The tender in which rates are to be quoted should be properly bound and sealed. In case of loose / spiral bound submission of tender, the tender shall be liable for rejection (In case of the downloaded tender documents from the internet).
- 9 If during the opening of tender or during the process of tender finalization, it is detected that the tenderer has submitted tender documents after making any changes/additions/deletions in the tender documents from the web site, the offer shall be summarily rejected and the EMD deposited by the tenderer shall be forfeited in addition to any action as per the prevalent rules.

### **DECLARATION OF RELATIVES**

#### (To be given by Tendering Agency)

All near relatives of any BSNL employee either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The detailed guide lines in this regard are given in the following paragraph.

i) The near relatives for this purpose are defined as:-

(a) Members of a Hindu Undivided family.

(b) They are husband and wife.

(c) The one is related to the other in the manners as father, mother, son(s) & son's wife (daughter in law), Daughter(s) & daughter's husband (son in law), brother(s) & brother's wife, sister's husband (brother in law).

- iii) As per Government of India's CCS conduct rule 4, No Govt servent shall in the discharge of his official duties deal with any matter or sanction any contract to any company or for any other person if any member of his family is employed in that company or firm or under that person or if he or any member of his family is intersested in such matter or contact of his official superior. This clause is applicable to all BSNL employees and in view to this as soon as any BSNL employee becomes aware of the above aspect, he must intimate this to the prescribed authority. For Non-Executive employee this authority is SSA head/ Circle head/Chief Engineer / Chief Arch./ Corporate Office under which he is posted. For Executive employee (at Present some of them are called Gazetted Officers) the prescribed authority for this porpuse is Circle head/Chief Engineer / Chief Arch./ Corporate Office under whom he is posted.
- (a) The company or firm or any other person is not pemitted to tender for works in BSNL unit in which his near relative(s) is/are posted. The unit is defined as SSA/Circle/Chief Engineer / Chief Architect / Corporate Office for executive employees (including those called as gazetted officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the unit as defined above where he is going to apply for tender/work. In case of proprietorship firm certificate will be given by the properietor, for partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and EMD / SD will be forbeited at any stage whenever it is so noticed. The department will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

(b) In respect of case where the tender notice / work related orders have been issued and are waiting for submission the concerned unit should issue corrigendum for inclusion of above clause. However, here tender / work related documents have been opened and are waiting for finalization the certificate may be taken from the company or firm or any other concerned person giving details of the relative employed in the jurisdiction of the tender. The company or firm or the person concerned will not be debarred in this case but his work will be kept under properwatch to avoid any further complaint. Further, the relative will not be involved in the decision making & execution of the work.

(c) Where the tenderers or the work are already in operation (or awarded) the tenderer may be requested to give details of relatives employed in the jurisdiction of the tender in such cases the tenderer will be allowed to continue the work but special watch may have to be kept about his performance to avoid any complaint. The concerned relative will not be involved in execution & sattlement of claims of the contractor.

- 1 Tenders will be issued to eligible B.S.N.L. as well as non B.S.N.L. contractors, provided they produce definite proof from the appropriate authority of having completed similar work of magnitude as specified in Eligibility criteria.
- 2 Agreement shall be drawn with the successful tenderer on prescribed Form No.8 which is available as a Govt. of India Publication; Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
- 3 The time allowed for carrying out the work will be As per NIT from the 10th Day after the date of written orders to commence the work or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any indicated in the tender documents.
- 4 The site for the work is available.
- 5 Receipt of applications for issue of forms will be stopped by 16:00 Hrs before four days of the date fixed for opening of tenders. Issue of tender forms will be stopped three days before the date fixed for opening of tenders.

Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms and conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer (E), BSNL Electrical Division,Shillong between hours of 11.00 A.M to 04.00 P.M. every day except on Sunday and Public Holidays. - 6 The tenderer must produce a Chartered Accountant Certificate in the revised form as modified under Ministry of Finance CBDT Circular No.153/191/2002-TPL dt.13-2-2003 as amended from time to time before tender papers can be sold to him.
- 7 Tenders, which should always be placed in sealed envelope, with the name of work and due date written on the envelopes, will be received by the Executive Engineer (E), BSNL Electrical Division, Shillong & the same will be opened by him or his authorised representative in his office as mentioned in NIT.
- 8 The tender shall be accompanied by earnest money, (unless exempted) of Rs. As per NIT in CDR/FDR/DD/BG (as specified) of a scheduled Bank issued in favor / pladge of Accounts Officer (Cash) BSNL, O/o The GMTD, Aizawl & Payable at Aizawl the amount being credited to Nationalized Bank.

Copies of other drawings and documents pertaining to the work will be open for inspection by the tenderers at the office of the abovementioned officer.

Tenderer are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may requisite and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed.

The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plants, etc. will be issued to him by the BSNL and local conditions and other factors having a bearing on the execution of the work.

- 10 The competent authority on behalf of the BSNL does not bind himself to accept the lowest or any other tender, and reserves to him the authority to reject any or all of the tenders received without the assignment of a reason. All tenders in whom any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected. Conditional tenders or tenders with conditional rebate shall be summarily rejected.
- 11 Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited. The tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 12 The competent authority on behalf of the BSNL reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

- 13 The contractor shall not be permitted to tender for works in the B.S.N.L. Electrical Zone (Responsible for award and execution of contracts) in which his near relative is posted in any capacity in BSNL in that Zone. He will also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any person employed in BSNL, in that Zone. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of BSNL.
- 14 No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractors' service.
- 15 The tender for the works shall remain open for acceptance for a period of ninety days, from the date of opening of tenders. If any tenderer withdraws his tender before the said period or makes any modifications in the terms and conditions of the tender which are not acceptable to the BSNL, then BSNL shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
- 16 The Notice Inviting Tender shall form a part of the contract document. The successful tenderer /contractor, on acceptance of his tender by the Accepting Authority, shall within 10 days from the stipulated date of start of the work sign the contract consisting of: -
- a The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

- 2 The bidder shall quote only Net rate excluding GST on Goods & Services. All taxes except CGST, SGST, UTGST and IGST if any, required to be paid on the invoices shall be borne by the supplier. The Labour welfare Cess & TDS as per the Govt. regulations will be recovered from the contractor. No concession form will be issued by the BSNL.
- 3 No additional condition whatsoever will be accepted for Turn Over Tax / Sales Tax / GST on works contract. In case of additional conditions for the payment of such taxes by the contractor the tender may be liable to be summarily rejected by the accepting authority. No conditional offer shall be entertained and the offer will be rejected.
- 4 Firm has option to deposit Earnest Money in form of Bank Guarantee for this work in attached format and manner wherever the amount of EMD is more than Rs. 20,000/-
- 5 All materials to be used on this work by the contractors shall be got approved from the Engineer -in-charge before installation at site. Unapproved materials if brought to site of work shall have to be removed immediately by contractor at his cost and risk.

- 11 Safety precaution and other site precautions: The firm shall adhere to, while executing the contract, the relevant safety rules of the Government of India. Any accident or damage during work will be the responsibility of the agency and BSNL will not entertain any claim, compensation, penalty etc. on this account or on account of non observance of any other requirement of law relevant to this work.

(b) In exceptional situation where the requirement is of an emergent nature and it is necessary to ensure continued supplies from the existing venders, the purchaser reserves the right to place repeat order up to 50% of the quantities of goods and services contained in the running tender /contract within a period of twelve months from date of award of work at the same rate or a rate negotiated (downwardly) with the existing venders considering the reasonability of rates based on prevailing market conditions and the impact of reduction in duties and taxes etc.

- 24 Loading, unloading, transportation, insurance etc shall be included in their offer.
- 25 All the material will be under the charge of contractor till it is completed and handed over. No materials will be removed from site without written permission of Engineer in charge.
- 26 (a) Termination of contract on death of contractor

Without prejudice of any of the rights or remedies under this contract, if the contractor dies, the Engineer in-charge on behalf of the BSNL shall have the option of terminating the contract without compensation to the contractor.

# (b) Indulging of contractor in criminal / Antisocial activities and cases under investigation / charge sheeted by CBI or any other Government agencies etc.

If the CBI / Independent External monitor (IEM) / Income Tax / Sales Tax / Central Excise / Custom Departments recommends such a course-Action will be taken as per the direction of CBI or concerned department.
